We, the undersigned, with other persons being desirous of forming a corporation for nonprofit purposes, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

#### ARTICLE I

#### Name

The name of this corporation is ISO-RIVOLTA AUTO MUSEUM, INC.

## ARTICLE II

#### Purposes

The general nature of the objectives and purposes of this corporation shall be to import, acquisition and display classic automobiles.
