The undersigned acting as incorporators of the corporation pursuant to Chapter 617, Florida Statutes adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation shall be HAITI HELP CENTER FOR THE POOR, INC.

ARTICLE II

TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE III

PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be 6351 Lake Worth Road, Suite 109, Lake Worth, Florida 33463.

ARTICLE IV

PURPOSE

The specific purposes for which the corporation is organized are to provide educational opportunities for children, medical, dental and health care, vocational training and food for the hungry, in a Christian educational environment, for Haitian nationals, and to make the Gospel of Jesus Christ available to the Haitian community by meeting both physical and spiritual needs.

#### ARTICLE V

##### METHOD OF ELECTION OF DIRECTORS

The manner in which the directors are to be elected shall be as provided in the By-Laws.

#### ARTICLE VI

##### CORPORATE POWERS

The corporate powers of this corporation are those provided in Section 617.0302 Florida Statutes except for those activities prohibited to an organization exempt under the provisions of Sections 501(c)(3) and 501(k) of the Internal Revenue Code of the United States.

#### ARTICLE VII

##### REGISTERED AGENT
