OF

RATPACK WRESTLING CLUB, INC.
A NON-PROFIT CORPORATION

ARTICLE I

The name of this corporation shall be RATPACK WRESTLING CLUB, INC.

ARTICLE II

The purpose and general nature of the objectives for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

To promote the personal, educational and athletic development of students interested in competitive amateur wrestling.

To engage in any activity incidental or conducive to the attainment of the purposes of this Corporation.

To engage in any activity that lawfully can be conducted by a Corporation organized under Chapter 617.001, et. seq., Florida Statutes.

ARTICLE III

Other purposes and objectives of the Corporation shall be:

1. Dissemination of information concerning the sport of wrestling and the activities of amateur wrestling groups to foster an interest in the sport of wrestling among middle school, high school and college students.
2. To sponsor wrestling tours, clinics and competitions.
3. To engage in other activities and functions as are proper and in furtherance of the goals and purposes of the Corporation.

4 To accept gifts and contributions, and to conduct fundraising activities in furtherance of the goals and purposes of the Corporation.

5 The Corporation shall be subject to the following provisions:

a. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, directors, officers or other private persons except that Corporation shall be authorized and empowered to pay reasonable compensation for services rendered;

b. No part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the Corporation shall not participate in or intervene (including publishing or distribution of statements) any political campaign on behalf of any candidate for public office;

c. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c) of the Internal Revenue Code of 1986 or corresponding provisions of any future United States Internal Revenue law; and,

d. Upon the dissolution of the Corporation and after paying or making provisions for payment of all liabilities of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IV

The qualifications and admission of members shall be as follows:

A. Qualifications. Any individual who subscribes to the purposes and basic policies of the Corporation may become a member of the Corporation subject only to compliance with the provisions of the By-Laws.

B. Annual Dues. Membership shall also require the payment of Annual Dues in accordance with the By-Laws of the Corporation

ARTICLE V

THE TERM OF EXISTENCE OF THIS CORPORATION SHALL BE PERPETUAL.

ARTICLE VI

ARTICLE VII

ARTICLE VIII

The affairs of the Corporation shall be managed by its Board of Directors, who shall be elected by the members of the Corporation in the manner and serve for the terms as prescribed in the Corporation's By-Laws. The Board of Directors may delegate specific duties and responsibilities to its corporate officers as prescribed in the Corporation's By-Laws.

ARTICLE IX

The number of initial Directors constituting the Board of Directors shall be three (3) until their successors shall be elected to serve. The number of Directors of the

Corporation may be increased or decreased, but shall never consist of less than three
(3) Directors. The following individuals shall serve as the initial Directors:

ARTICLE X

The Articles of Incorporation or By-Laws may be altered, amended or repealed and new Article of Incorporation or By-Laws may be adopted by a two-thirds (2/3) vote of all the Directors or a sixty-five percent (65%) majority of the voting members of the Corporation present at any annual meeting or duly summoned special meeting of the Directors. At least ten days prior written notice setting forth the proposed action and specific Articles or By-Laws to be added, deleted, amended or changed and time and place of meeting shall be given to all members of the Corporation.
