ARTICLES OF INCORPORATION

OP

CHABAD LURAVITCE OF DOWNTOWN FORT LAUDERDALE II, INC.

A Florida Corporation Mot-For-Profit

The undersigned incorporator, for the purpose of forming a corporation not-for-profit pursuant to the laws of the State of Florida, Florida Statutes, Chapter 617, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: CEARAD LUBAVITCE OF DOWNTOWN FORT LAUDERDALE II, INC.

ARTICLE II - PURPOSE

The purposes for which the Corporation is organized are as follows:

- 1. To operate as a corporation not-for-profit pursuant to Chapter 617 of the Florida Statutes.
- 2. To provide Orthodox Jewish religious, educational and social services to the Jewish community and to the community at large, and for all other lawful purposes which this corporation may undertake and maintain its status under the Internal Revenue Code Section 501 (c) (3).
- 3. Generally to have and exercise all rights and powers conferred on nonprofit corporations under the laws of the State of Ploxida, or which may hereafter be conferred, including the power to contract, rent, buy, or sell personal or real property; provided

however, that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.

4. Notwithstanding any of the above statements of purposes and powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherence of the primary purpose of this corporation.

ARTICLE III - MEMBERS

The qualification for members and the manner of their admission to membership shall be regulated by the by-laws for this corporation. Qualification shall be available only to persons who have interest in the promulgation and furtherance of the teachings of Orthodox Judaism in general, and of the Chabad Lubavitch teachings in particular.

ARTICLE IV - TERM OF EXISTENCE

This Corporation shall exist perpetually unless sooner dissolved by law.

ARTICLE IX - BY-LAWS
