# ARTICLES OF INCORPORATION OF BOYS AND CIRLS CLUB OF BREVARD, INC.

(A Corporation Not for Profit)

WE, the undersigned residents of the State of Florida, being eighteen (18) or more years of age, do hereby associate ourselves together for the purpose of forming a corporation not for profit, under the laws of the State of Florida, pursuant to the following Articles of Incorporation:

#### ARTICLE I

#### Name

The name of this corporation is BOYS AND GURLS CLUB OF BREVARD, INC.

#### **ARTICLE II**

#### Principal Office; Initial Registered Office and Agent

The address of the principal office and the mailing address of the corporation is 96 Willard Street, Suite 302, Cocoa, Florida 32922. The street address of the corporation's initial registered office is 96 Willard Street, Suite 302, Cocoa, Florida 32922. The name of the initial registered agent of the corporation at that address is JAMES S. THERIAC, III. A written acceptance of appointment as registered agent is provided with these articles.

#### **ARTICLE III**

#### Statement of Corporate Nature

This is a corporation not for profit organized solely for general charitable purposes pursuant to the Florida Not For Profit Corporation Act set forth in Chapter 617 of the Florida Statutes.

#### ARTICLE IV

#### Duration

The period of duration of this corporation not for profit shall be perpetual.

#### ARTICLE V

#### General and Specific Purposes

The specific and general purposes for which this corporation is formed are to provide relief to the poor and underprivileged and to promote social welfare by promoting and providing the youth of Brevard County, Florida with special concern for those youth from economically disadvantage situations, with the opportunity to develop the qualities needed to become responsible citizens and leaders of the community regardless of race, color, creed, or national origin.

The general purposes for which this corporation is organized are exclusively religious, c<sup>1</sup>-aritable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue Law. Notwithstanding any other provisions of these articles of incorporation, the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income taxes under section 501(c)(3) of the Internal Revenue Code, as amended, or the corresponding provision of any future United States Internal Revenue Law.

#### **ARTICLE VI**

#### Non Member Corporation

This corporation shall not be a member corporation.

#### **ARTICLE VII**

#### **Nonstock Corporation**

This corporation shall be nonstock and no dividends or pecuniary profits shall be declared or paid.
