MEDICORP HOME HEALTH CARE SERVICES, INC.

1. The preamble of the Articles of Incorporation of Medicorp Home Health Services, Inc., is hereby deleted in its entirety and replaced with the following:

The undersigned, acting as incorporator of a corporation under the Corporation Act of the State of Florida, adopt the following articles of incorporation.

2. Article III of the Articles of Amendment to Articles of Incorporation of Medicorp Home Health Care Services, Inc. ("Corporation") dated August 30, 1995, is hereby deleted in its entirety and replaced with the following:

ARTICLE III

Corporation is organized for the purpose of engaging in any lawful act or activity for which a corporation may be organized, so far as is or may be permitted by the laws of the State of Florida, including but not limited to establishing, managing, and operating a home health care agency and related home health care enterprises for profit.

3. The following article of incorporation is adopted and added to the Articles of Incorporation of Medicorp Home Health Care Services, Inc.:

ARTICLE X

The capital stock of the Corporation shall be 1000 shares of common stock having a par value of \$.01 per share.

4. The foregoing Amendment was adopted by all the directors of the Corporation on the 19th day of May, 1997. The directors voting in favor of the foregoing amendment was sufficient for approval. As there were no shares, shareholder approval was not required.
