Before me, the undersigned authority, personally appeared Mark Delvaux, who being duly sworn states as follows:

1. My name is Mark Delvaux. I am the President and Chief Executive Officer of AlphaNet, Inc. ("AlphaNet"). The facts in this affidavit are based on my own personal knowledge and if called as a witness I could, and would, testify competently to these facts.

2. AlphaNet has been registered with the Florida Department of State since July 18, 1995, and is a not-for-profit 501(c)(3) organization founded in 1995 with a mission to provide innovative health management and customized care to individuals with Alpha-1 Antitrypsin Deficiency while funding research for a cure.

3. AlphaNet is located and operates its business at 3300 Ponce de Leon Boulevard, Coral Gables, FL 33134.

4. On or about December 14, 2023, AlphaNet discovered a filing with Florida's Department of State, Division of Corporations on SunBiz in the name Alphaserved LLC ("Alphaserved").

5. In this filing, Alphaserved falsely listed its principal place of business as 3300 Ponce de Leon, Coral Gables, FL 33134.

6. Alphaserved is not affiliated with AlphaNet.

7. AlphaNet did not authorize Alphaserved to use 3300 Ponce de Leon, Coral Gables, FL 33134 as its principal place of business and Alphaserved does not have permission to operate at 3300 Ponce de Leon, Coral Gables, FL 33134.

8. Alphaserved's filing of its entity with Florida's Division of Corporations on December 7, 2023, is false, fictitious, and fraudulent. **See Exhibit 1.**

9. Alphaserved's filing of its Articles of Organization with the Secretary of State on December 7, 2023, is false, fictitious, and fraudulent. **See Exhibit 2.**

10. Alphaserved's filing of its Certificate Status Request Form with the Business Certificate Services of Florida, which uses AlphaNet's address is false, fictitious, and fraudulent. **See Exhibit 3.**

11. As a result of Alphaserved's unauthorized filing, AlphaNet issued a cease and desist letter to Alphaserved on December 28, 2023. **See Exhibit 4.** As of the date of submission of this notarized Statement of Fact, Alphaserved has not responded to the cease and desist letter.

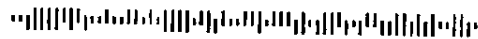

**Re: FRAUDULENT FILINGS WITH FLORIDA'S DEPARTMENT OF STATE**

To Whom it May Concern:

This law firm represents AlphaNet, Inc. ("AlphaNet"). This correspondence addresses your unlawful use of AlphaNet's address for fraudulent filings with the Florida Department of State, Division of Corporations. In those filings, you falsely reported to the Department of State that Alphaserved and its registered agent reside at AlphaNet's address, 3300 Ponce de Leon, Coral Gables, FL 33134 (the "AlphaNet address"). *See* Ex. A (Alphaserved, LLC's false filings).

**YOU ARE HEREBY ADVISED THAT YOU ARE HEREBY COMMANDED  
TO CEASE AND DESIST FROM ANY AND ALL USE OF ALPHANET'S  
ADDRESS AND LIKENESS.**

As you well know, Alphaserved has no affiliation with AlphaNet and does not presently—and has never—resided or operated at the AlphaNet Address. For the avoidance of any doubt, AlphaNet has been a registered Florida business since 1995, and it has not authorized any of you or Alphaserved to (1) use the AlphaNet address for any purpose; (2) represent to the State or the public that its business and registered agent are located at the AlphaNet address; or (3) represent that there is any affiliation whatsoever between Alphaserved and AlphaNet.

This letter serves as AlphaNet's formal demand that Alphaserved withdraw any and all fraudulent filings with the State, and delete any other filings, documents, and records using the AlphaNet address. As you may be aware, as the Department of State makes clear, submitting fraudulent filings to the Florida Department of State is a third degree felony criminal offense. *See* (<https://dos.fl.gov/sunbiz/manage-business/mind-your-sunbizness/sunbizness-identity-theft-resource-guide/florida-department-of-state-s-duties-and-records/>).

It is a third degree felony for a party to file a fraudulent document on the records of the Florida Department of State. Section 817.155, Florida Statute (F.S.), states,

*"A person may not, in any matter within the jurisdiction of the Department of State, knowingly and willfully falsify or conceal a material fact, make any false, fictitious, or fraudulent statement or representation, or make or use any false document, knowing the same to contain any false, fictitious, or fraudulent statement or entry. A person who violates this section is guilty of a felony of the third degree, punishable as provided in s. 775.082, s. 775.083 or s. 775.084."*

Your misappropriation of and false use of the AlphaNet address likewise subjects you to exposure for fraud and other civil claims by AlphaNet.

Finally, this is a legal demand for you to retain any and all potentially relevant evidence. Therefore you, your employees, accountants, representatives, consultants, investigators, attorneys, affiliates, agents, advisors, or assigns, or any entities or persons acting or purporting to act on your behalf, should take all necessary steps to retain and avoid the automatic deletion or archiving of any letters, emails, text messages, voicemails, voice-notes, social media posts, messages, and content of any kind, as well as any other hard copy or electronically stored information relating to Alphaserved's filings with the State and Sunbiz.org, AlphaNet, and any related matter.

Nothing herein is nor should it be construed as a waiver of any rights or remedies AlphaNet has or may have. All rights reserved.

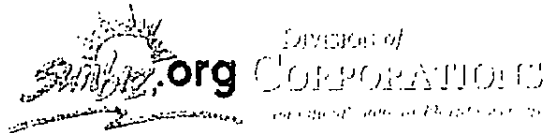
