ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
FAR AND AWAY MISSIONS, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendments to its articles of incorporation.

FIRST: Amendments adopted: articles of incorporation I, III, IV, and V are amended to read as follows:

Article I

Name

The name of the non-profit corporation shall be: FAR AND AWAY MISSIONS, INC., and as such it shall constitute a body corporate, with perpetual succession, and shall have power to sue and be sued, to contract and be contracted with, and use a corporate seal, and to hold the title to real and personal property as provided in Article III.

Article III

Purpose

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so

disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article IV

Manner of Election of Directors

The manner in which director(s) are to be elected shall be provided for in the bylaws of the non-profit corporation. The number of directors constituting the board of directors is three (3) and the names and addresses of the persons who are to serve as the directors are:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing of distributions of statements) any political campaign on behalf of any candidate for public office.

Article V

Limitation of Corporate Powers

The corporate powers of this non-profit corporation are as provided in section 617.0302 of, Florida Statutes. Notwithstanding any other provision of these articles, this organization shall not carry an any activity not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

SECOND: The date of adoption of the amendments was March 15, 1996.

THIRD: Adoption of Amendment.
