ARTICLE OF INCORPORATION
OF
YOUTH SECURITY OUTREACH CLUB INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated pursuant to Chapter 617, Florida Statutes as amended of the Laws of the State of Florida, applicable to corporations not for profit under the following proposer Charter:

ARTICLE I

The name of this corporation is Youth Security Outreach Club INC.

ARTICLE II

The purpose for which the Corporation is formed are:

- (a) To involve youth in activities designed to help make a better community.
- (b) To work with youth in the area of crime prevention; decrease juvenile delinquency; to encourage youth to stay in school and thereby curb the growing drop-out rate.
- (c) To make jobs and job training available to youth by working with both profit making and non-profit making businesses and corporations.
- (d) To teach youth thrift, investment and management.
- (e) To prepare youth of the community to become productive members of society.

ARTICLE III

Any person who resides in the St. Petersburg area and who subscribe to the purpose of this Corporation is eligible for membership upon approval by a majority vote of the Corporation, at any regular meeting of the Corporation.

ARTICLE IV

This Corporation shall have perpetual existence.

ARTICLE V

The registered agent of this Corporation is Miss Needa Spells, of 220 39th Street South, St. Petersburg FL 33712.

The principal office of this Corporation is at 220 39th Street South, St. Petersburg, FL 33712.

ARTICLE VI

The affairs of this Corporation are to be managed by a President, Vice President, Secretary and Treasurer who shall be elected bi-annually by the members of the Corporation as prescribed in the by-laws.

ARTICLE VII

ARTICLE IX

The By-Laws of this Corporation may be amended, altered or rescinded by a two-thirds (2/3) majority of the Board of Directors subject to the approval by a three-fifths (3/5) majority of the membership at any regular meeting of the Corporation.

ARTICLEX

The article of Incorporation may be amended, altered or revised by a three-fourth (3/4) vote of the delegation present at any annual meeting providing that all such changes have been approved by a two-thirds (2/3) vote of the Board of Directors prior to the annual meeting

ARTICLE XI

Upon dissolution of this Corporation, all of the assets remaining after all costs and expenses of such dissolution shall be distributed by the Board of Directors to such organizations which have qualified for tax exemption under Section 501 (c) (3) of the Internal Revenue Code as recommended or superseded to be used for Public Welfare purposes

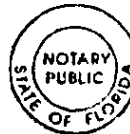
