This letter is being sent to request a waiver of the fee for reinstatement of a non-profit organization. When we sent our Uniform Business Report in May of 2000, it was apparently returned for an omission. Your office mailed it back on June 5, 2000, according to your records, but the Band Boosters never received the letter requesting an amendment. In fact, the current board was unaware that your office had dissolved our corporation until May 1, 2001, when we called to inquire as to the whereabouts of our annual renewal form.

By way of explanation, our corporation exists for the sole purpose of assisting the Sebastian River High School band and its director by providing the students with additional funds that our local school board would not provide. We manage a very large annual budget. All of our board members have full time jobs, but none are paid for their work with the Band Booster organization. We are not housed in an office building, but use the school and band room for our gatherings and activities. Therefore, the school address is the only fixed address we can use, since most of our officers change annually. As you can imagine, it is challenging to ensure that we get our mail in a timely manner, or even at all.

The annual fee of \$61.25, plus the additional \$8.75 for a certificate of status, is enclosed with the anticipation that you will understand our inadvertent omission last year, and allow us to waive the fee for reinstatement. We are aware that this can only be allowed one time. Thank you for your time and attention.
