ARTICLES OF INCORPORATION OF  
HARVEST TEAM MINISTRIES, INC., a Not For Profit Corporation

The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is HARVEST TEAM MINISTRIES, INC., a Not For Profit Corporation.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be 916 May Avenue, Holly Hill, Volusia County, Florida 32117.

ARTICLE III - PURPOSE

The specific purposes for which the corporation is organized are:

A Christian ministry for the purpose of evangelizing, and teaching the word of God and inspiring other Christians to evangelize. This purpose of this ministry will be fulfilled by distribution of literature, teaching and preaching in Christian churches and other public gatherings, providing assistance to the disadvantaged, and other similar activities.




CERTIFICATE OF DESIGNATION
