OF

ARTICLE I

The name of the corporation is ALPHA RECREATION CORPORATION, INC., and the initial principal address of the corporation is 3210-B Tanager Court, Tallahassee, Florida 32308.

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLE III

This organization is organized exclusively for religious and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law).

The specific purpose of ALPHA RECREATION CORPORATION, INC. is to provide a retreat for ministers, Pastors and church leaders in need of rest. Further to provide a retreat and recreation to troubled youths and elderly people.

ARTICLE IV

The qualifications for members and the manner of their admission are set forth in the bylaws of the corporation.

ARTICLE V

The street address and city of the initial registered office is 3210-B Tanger Court, Tallahassee, Florida 32308, located in Leon County, and the name of its initial registered agent at such address is Lane Roberts.

ARTICLE VI

The number of directors constituting the initial Board of Directors is three.

The manner of election of Directors is set forth in the Bylaws of the corporation.

ARTICLE VII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the

federal, state, or local government for exclusive purpose.

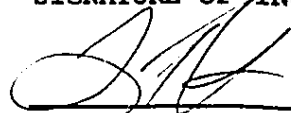

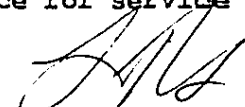
