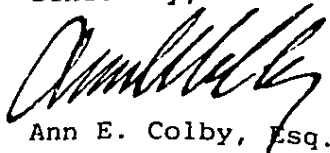

ARTICLES OF INCORPORATION  
OF

AVEC AMIS (WITH FRIENDS), INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a nonprofit corporation.

ARTICLE I

The name of this corporation shall be: AVEC AMIS (WITH FRIENDS), INC.

ARTICLE II

The principal place of business of this corporation shall be: 7110 Partridge Lane, Orlando, FL 32807. The mailing address of this corporation shall be P.O. Box 574601, Orlando, FL 32857.

ARTICLE III

The object and purpose of the corporation, and the general nature of the business or businesses to be transacted, shall be:

1. Providing long term rental housing for adults (married couples, single individuals or any other social arrangement) based primarily on a diagnosis of HIV/AIDS or other life threatening disease.
2. Working in connection with existing SAOs (Aids Support Organizations), CBOs (Community Based Organizations) and any other groups which deal with housing assistance matters.
3. Providing emotional support and financial assistance in the area of assisted housing for those individuals housed by this corporation.
4. Developing a community network to assist in providing a supportive, drug-free, clean and safe atmosphere in which the goals of this organization can be realized.
5. Providing factual information concerning AIDS, AIDS related diseases, diabetes and other life threatening diseases to the general public in conjunction with existing ASOs and CEOs.
6. Conducting any other lawful business as may be conducted pursuant to the provisions of Chapter 617 of the Florida

Statutes, ''Corporations Not For Profit''.

#### ARTICLE IV

This corporation is organized pursuant to the General Nonprofit Corporation Law of the State of Florida and does not contemplate pecuniary gain or profit to the members thereof and it is organized for nonprofit purposes.

#### ARTICLE V

The directors of this corporation shall be elected in the manner and at the times as set forth in the corporate By-laws.

#### ARTICLE VI

The name and address of the initial registered agent is: Lynne Watkins, 7110 Partridge Lane, Orlando, FL 32807.

#### ARTICLE VII

#### ARTICLE VIII

The authorized number and qualifications of members of the corporation, the different classes of membership, if any, the property, voting and other rights and privileges of members shall be as set forth in the By-Laws.

#### ARTICLE IX

The property of this corporation is irrevocably dedicated to housing purposes and no part of the net income or assets of this organization shall ever insure to the benefit of or be distributable to its members, trustees, officers, directors, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes as set forth in Article III. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to

any candidate for public office. Notwithstanding any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue code, or by the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE IX

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

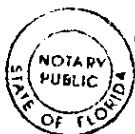
