ARTICLE I - NAME

THE NAME OF THIS CORPORATION SHALL BE THE CHRISTIAN COUNSELING CENTER, INC.

ARTICLE II - DURATION

THE DURATION OF THIS CORPORATION IS PERPETUAL, UNLESS VOLUNTARILY DISSOLVED BY THE OFFICERS OR DIRECTORS, ACCORDING TO THE LAWS OF THE STATE OF FLORIDA.

ARTICLE III - THE PURPOSE

THE GENERAL PURPOSE OF THIS CORPORATION IS FOR COUNSELING AND TEACHING THE WORD OF GOD, OPERATING A CHRISTIAN FELLOWSHIP CENTER, WHEREBY WORSHIP SERVICES WILL BE HELD ON THE LORD'S DAY, INCLUDING RELIGIOUS WEEKLY MEETINGS, AND ANY OTHER MEETINGS THAT MAY BE DEEMED NEEDED OR NECESSARY.

TO OPERATE FOR THE ADVANCEMENT OF RELIGION BY REACHING OUT AND RECLAIMING OUR FAMILIES FOR JESUS CHRIST, THRU COUNSELING, BIBLICAL PRECEPTS, RESTORING LOVE AND RESPECT, GLORIFYING GOD BY RELATING HIS AGAPE LOVE TO THE COMMUNITY AND TO THE WORLD THRU INTER-CHANGE.

TO ORGANIZE TO KEEP UNITY OF THE SPIRIT IN A BOND OF LOVE, PEACE, HOPE, AND CHARITY. TO FUNCTION AS A RELIGIOUS AND CHARITABLE ORGANIZATION, AS WILL QUALIFY IT, AS AN EXEMPT ORGANIZATION UNDER THE EXISTING INTERNAL REVENUE CODE, AND ANY PROVISIONS OF ANY SUBSEQUENT FEDERAL TAX LAW, FOR THE PURPOSE OF SOLICITING AND DISTRIBUTING CHARITABLE GIFTS TO WORTHY PERSONS OR ORGANIZATION.

TO CONDUCT A COMMUNITY WIDE OUT REACH MINISTRY PROGRAM, WHICH WILL INCLUDE, BUT NOT BE LIMITED TO RELIGIOUS SERVICES IN THE CORRECTION FACILITIES, NURSING HOMES, HOSPITALS, CHILDREN DETENTION CENTERS, ETC. AS NEW COMMITTEES ARE FORMED, AND NEW NEEDS ARE DEVELOPED, TO MEET THOSE NEEDS EXPRESSED FROM NON-DENOMINATIONAL COMMUNITY GATHERING.

TO SPONSOR RELIGIOUS EDUCATION THROUGHOUT THE COMMUNITY. TO PROMOTE SPIRITUAL GROWTH, TO TEACH BIBLICAL PRINCIPLES, TO STRESS THE NEED FOR INTER-CHANGE AND TO ENCOURAGE CHARACTER CHANGE AND CORRECTION.

TO PROVIDE CHRISTIAN COUNSELING TO THE GENERAL PUBLIC, INCLUDING, BUT NOT LIMITING OUR SERVICES TO ALL INDIVIDUALS, ORGANIZATION, GROUPS, INSTITUTIONS, ETC.

TO PERFORM PASTORIAL DUTIES INCLUDING, BUT NOT LIMITED TO THE ORDAINING, TRAINING, CERTIFYING AND LICENSING OF INDIVIDUALS. THE INITIAL LOCATION SHALL BE 639 N. W. 9 AVENUE, FT. LAUDERDALE, FLORIDA, AND SUCH OTHER PLACES AS THE DIRECTORS MAY DECIDE FROM TIME TO TIME.

ARTICLE IV - AUTHORIZED STOCK

THIS CORPORATION IS AUTHORIZED TO ISSUE NO STOCKS

ARTICLE V - INITIAL BOARD OF DIRECTORS

INITIALLY THIS CORPORATION SHALL HAVE ONE PRESIDENT, AND ONE VICE-PRESIDENT. THE NUMBER OF DIRECTORS MAY BE EITHER INCREASED OR DIMINISHED, FROM TIME TO TIME, BY THE BY-LAWS, BUT SHALL NEVER BE LESS THAN ONE. ARTICLE VIII - AMENDMENT

THIS CORPORATION RESERVES THE RIGHT TO AMEND OR REPEAL ANY PROVISIONS CONTAINED IN THESE ARTICLES OF INCORPORATION, OR ANY AMENDMENT HERETO, AND ANY RIGHT CONFERRED UPON THE SHAREHOLDERS IS SUBJECT TO THIS RESERVATION.

ARTICLE IX - TAX ELECTION

THE DIRECTORS AND OFFICERS OF THE CORPORATION HAS ELECTED TO PETITION THE FEDERAL GOVERNMENT FOR TAX EXEMPT STATUS AND A RELIGIOUS ORGANIZATION. PAPERS BE FILED FOR THIS STATUS AS SOON AS IT IS ALLOWED, AND THE PAPER WORK IS COMPLETED.

ARTICLE X - INDEBTEDNESS

THE CORPORATION SHALL HAVE NO LIMITATIONS, ON THE AMOUNT OF INDEBTEDNESS TO WHICH THE CORPORATION MAY SUBJECT ITSELF TO, IN THE PURSUIT OF ITS RELIGIOUS AND CHARITABLE PURPOSES. NOR SHOULD THERE BE ANY LIMITATIONS ON THE AMOUNT OF CONTRIBUTIONS RECEIVED OR DISTRIBUTED TO MEET THE NEEDS OF THE CORPORATION OR THE PEOPLE IT SERVES.

ARTICLE XI - DISSOLUTION

IN THE EVENT THAT THE SAID CORPORATION IS DISSOLVED, WHETHER BY AGREEMENT OF THE DIRECTORS OR OFFICERS OR BY A COURT ACTION, THE SAID CORPORATION SHALL REMAIN IN EXISTENCE UNLESS IT IS ORDERED OTHERWISE BY AN ORDER OR COURT DECREE, FOR THE PURPOSE OF LIQUIDATING THE AFFAIRS OF THE CORPORATION. THE THEN OFFICERS AND DIRECTORS OF THE SAID CORPORATION SHALL CONTINUE TO HOLD SUCH POSITIONS AND SHALL BECOME THE TRUSTEE FOR THE PURPOSE OF LIQUIDATING THE SAID CORPORATION. IN SUCH DISSOLUTION ALL OF THE ASSETS OF THE SAID CORPORATION SHALL BE TURNED INTO CASH IN SUCH MANNER AS THE SAID TRUSTEES, IN THEIR BEST JUDGMENT SHALL DETERMINE AND FROM THE CASH THUS OBTAINED ALL THE DEBTS AND OBLIGATIONS OF THE SAID CORPORATION SHALL BE FULLY PAID. IF ANY MONEY OF THE SAID CORPORATION THEN REMAIN IN THE HANDS OF THE SAID TRUSTEES, IT SHALL BE DONATED TO AN ORGANIZATION AS AGREED UPON BY THE TRUSTEE.

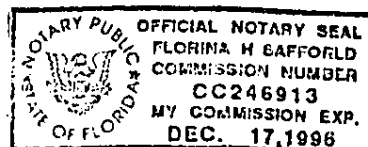

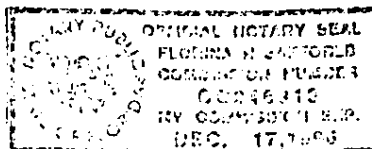

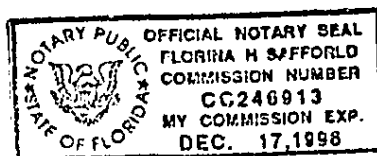
