

ARTICLES OF INCORPORATION OF AIDS EDUCATION AND INFORMATION FUND, INC.

(A Florida Nonprofit Corporation)



ARTICLE I. NAME

The name of this corporation shall be AIDS EDUCATION and INFORMATION FUND, INC.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Department of State, Division of Corporations. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE
