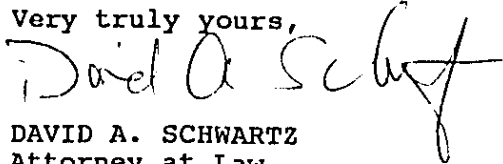

ARTICLES OF INCORPORATION
OF
BIKKUR CHOLIM OF KENDALL, INC.

I, the undersigned, hereby make, subscribe, acknowledge, and file these Articles of Incorporation for the purpose of becoming a not-for-profit corporation under Chapter 617, Florida Statutes.

ARTICLE I

IDENTIFICATION

The name of this corporation is BIKKUR CHOLIM OF KENDALL, INC., having a mailing address at Post Office Box 561044, Miami, Florida 33256-1044.

ARTICLE II

DURATION

This corporation shall have perpetual existence which shall commence at the date of the filing of these Articles with the Secretary of State.

ARTICLE III

CORPORATE NATURE

This is a not-for-profit corporation, organized solely for general religious, charitable and educational purposes pursuant to the Florida Corporations Not-for-Profit Law set forth in Section 617 of the Florida Statutes.

ARTICLE IV

GENERAL AND SPECIFIC PURPOSES

The specific and primary purposes for which this corporation is formed are:

- A. For the advancement of religious, charity, education

and any other related or corresponding purposes by the distribution of its funds for such purposes.

B. To operate exclusively in any other manner for such religious, charitable and educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or under any corresponding provisions of any subsequent federal tax laws, covering the distributions to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended, including private foundations and private operating foundations.

ARTICLE V

AUTHORIZED MEMBERSHIP CERTIFICATES

A. This corporation shall be authorized to issue five hundred (500) membership certificates.

B. All membership certificates issued by the corporation shall contain a statement on the face thereof that it is a not-for-profit corporation.

C. Except as otherwise prescribed by Florida law, each share shall entitle the holder thereof to one vote.

ARTICLE VI

REGISTERED AGENT AND OFFICE

The initial registered agent of this corporation and his address is as follows: Alexander M. Weinberg, Esquire, 9130 S. Dadeland Blvd., Suite 1609, Miami, Florida 33156.

ARTICLE VII

INCORPORATOR

ARTICLE VIII

LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes.

ARTICLE IX

MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed shall be determined by the corporate bylaws.

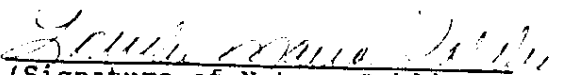

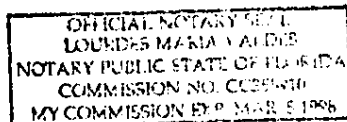

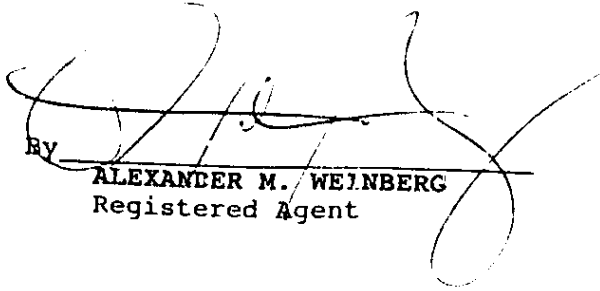
