#### ARTICLES OF INCORPORATION

A FLORIDA NONPROFIT CORPORATION LAHASSEE STATE

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

#### ARTICLE I NAME

The Name of the corporation shall be: THE RAINFOREST FOUNDATION, INC.

#### ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The Principal place of Business and Mailing Address of this Corporation shall be: 6001 s.w. 63rd Avenue Miami, Florida 33143

> ARTICLE III DURATION

The Duration of the Corporation is perpetual.

ARTICLE IV PURPOSES

The Purpose of the Corporation is as follows:

A. This Corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are:

- I. The raising of funds from the General Public, in the form of Donations, Gifts and Contributions, in accordance with the Internal Revenue Service guidelines and regulations governing the administration of Public Charities, in order to permit the Foundation to finance it's Environmental Preservation, Conservation, Educational and Promotional activities in the United States, Canada, Latin America and the Caribbean.
- 2. The Preservation of Natural Resources and the Scenic Beauty of the Rainforest in the United States, Canada, Latin America and the Caribbean, through Environmental Conservation of Soil, Water and other Ecological Factors subject to Progressive Management of the Ecosystem.
- 3. The Acquisition of Land for the Preservation of the Rainforest and other Fragile Ecosystems, in the form of establishing Nature Preserves in the United States, Canada, Latin America and the Caribbean.
- 4. The Establishment of Wildlife Sanctuaries or Reserves in the United States, Canada, Latin America and the Caribbean, especially for the protection and preservation of Endangered Species and their threatened Habitats.
- 5. The Establishment of Tree-Planting programmes in Suburban and Urban Neighbourhoods, for the purposes of Beautification, Energy Conservation, Prevention of Community Deterioration, and the Preservation of Local Ecosystems from Pollution and Unregulated Development.
- 6. The promotion of Environmental Educational Programmes in the form of Lectures, Forums, Seminars, Panels, Discussion Groups, Films, Slide Shows, Field Trips and Publications.
- 7. The Development and Promotion of Ecotourism, Alternative Rainforest Agricultural Initiatives, the Ethno-Botanical Study of Medicinal Rainforest Flora and Progressive Forest Management and other Innovative Projects that provide Economically Viable and Socially Desirable alternatives to Deforestation.

C. Provided, however, that the porporation shall not engage in any action which is not permitted to be carried on by Nonprofit Corporations under the Internal Revenue Code and no part of the Net Earnings of the Corporation shall inure to the benefit of, or be distributable to, its Members, Directors or Officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for Services rendered, and to make payments and distributions in furtherance of its stated purposes.

## ARTICLE V MANNER OF ELECTION OF DIRECTORS

The Manner in which the Directors are Elected or Appointed is stated in the Bylaws.

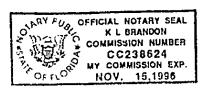
