THE ARTICLES OF INCORPORATION

A CORPORATION NOT FOR PROFIT

***** WE THE UNDERSIGNED, desiring to associate for the purpose of incorporating as a corporation, not for profit, under the provisions of Chapter 617 of FLORIDA Statutes, do hereby purpose the following as our Articles of Incorporation

***** ARTICLES I *****

THE GRAND ISLAND FREE METHODIST LIGHT and LIFE CHAPEL, Inc. shall be the legal and sovereign name of This Holy Corporation; and,

35720 COOGE CREEK ROAD Leesburg, FLORIDA 34788-2846 shall be the legal physical address of this corporation, and the Board of Trustees may from time to time designate a legal mailing address which shall reside within the State of FLORIDA

***** ARTICLES II *****

The general nature, objects and purpose for which this corporation is exclusively organized and operated are to promote the Christian Religion, and to promote the doctrine and experiences of full salvation as set forth in The Book of Discipline of The Free Methodist Church. This corporation shall receive and maintain funds of real and / or personal property, and subject to the restrictions and limitations hereinabove and hereafter set forth, use the whole or any part of the income therefrom and the principle thereof to do and preform all acts and things necessary for the proper conduct and management of the corporation

***** ARTICLES III *****

The qualifications for the membership and the election of trustees who shall be directors of the corporation shall be the same as the general rules and requirements for membership in The Free Methodist Church as set forth in the by laws (The Book of Discipline of The Free Methodist Church of North America.)

***** ARTICLES IV *****

The term for which this corporation is to exist shall be perpetual

***** ARTICLES V *****


The highest amount of indebtedness or liability of said corporation may subject itself, shall never

and mixed.


