The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

### ARTICLE I

## ARTICLE III PURPOSE

The purpose for which the corporation is organized exclusively for charitable, religious and purposes, including, for the purposes the ministration sacerdotal functions, the conducting of religious worship and making of distributions to organizations that qualify as organizations under Internal Revenue Code Section 501 (c)(3). to further this purpose the corporation shall have full power establish a church, purchase, lease or otherwise acquire to publish a newspaper or magazine, support missionaries, funds, and to do those things necessary to promulgate the Gospel an effective manner.

## ARTICLE X DISTRIBUTION OF PROPERTY AND EARNINGS

The property of this corporation is irrevocably dedicated to religious purposes and no part of the net earnings of the corporation shall be distributed to its members, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation (including the publication of distribution of statements) or on behalf of any candidate for public office.
