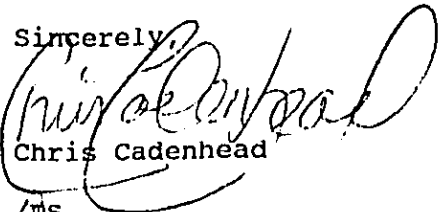

ARTICLES OF INCORPORATION  
for

The undersigned, acting as incorporator for the purpose of forming a corporation not for profit pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation.

ARTICLE I

The name of the corporation shall be NORTHWEST FLORIDA EQUESTRIAN AND RECREATION FOUNDATION, INC.

ARTICLE II

The principal street address and mailing address of this corporation shall be 501 North Ferdon Blvd., Crestview, Florida 32536. The registered agent at that address shall be William A. Barnhill.

ARTICLE III

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLE IV

The purpose for which the corporation is organized is to encourage participation in equestrian and recreational activities, and to raise funds to provide facilities and support for such activities.

#### ARTICLE V

The qualifications of the directors and the manner in which they will be appointed and/or elected will be stated in the by-laws of the corporation. The qualifications of members and the manner of their admission will be stated in the by-laws of the corporation.

#### ARTICLE VI

The number constituting the initial Board of Directors and officers of the corporation is four, and the names and addresses of the persons who are to serve initially are:

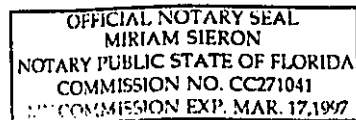

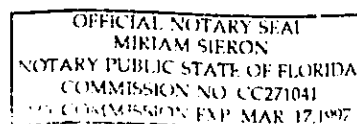
