Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for the charitable purposes and which has established its tax exempt status under Section(c)(3) of the Internal Revenue Code.
