ARTICLE I

The name of this organization shall be:

JESUS IS ALIVE MINISTRIES PRAISE AND WORSHIP
CENTER, INC.

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

The purpose of the corporation shall be: To operate a meeting hall for persons to gather together in fellowship and for religious activities. To administer to the whole person for their food, clothing and religious guidance. To promote good will and mutual understanding among the members of the community. To raise funds for the operation of the corporation. To have functions designed for the community in order to foster a greater interest in the well-being of the needy of the community. To have our members go into the community to spread the word of God and his salvation. In addition it shall, operate a rescue mission to help the needy by providing them with food, clothing and spiritual guidance. To operate a thrift store to employ needy persons and to raise funds to permit the operation of the mission. The corporation will serve itself as a cohesive group with a common voice in regards to its interests. This corporation shall be NOT FOR PROFIT.

The corporation shall have the following types of members who shall be admitted if they meet the following qualifications:

Any community minded person can qualify for membership in this corporation. The admission to membership of any interested individual will be governed and selected by the Board of Directors of this Corporation.

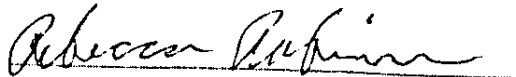
A Board of Director may be removed by a 2/3 vote by the other Board of Directors or upon the conviction of a felony crime.

The second class of voters shall be all those other members who are not on the Board of Directors and who have all the rights of a member of the Board of Director, except being able to cast a vote.
