

ARTICLES OF INCORPORATION
OF
UNION GENERAL DE TRABAJADORES DE CUBA

WE, The undersigned incorporator, hereby associate ourselves together and make, subscribe, acknowledge and file with the Secretary of State of Florida, these Articles of Incorporation for the purpose of forming a corporation not for profit under the provisions of Chapter 617 of the Florida Statutes do agree to the following:

ARTICLE ONE

The name of this Corporation should be UNION GENERAL DE TRABAJADORES DE CUBA, INC. located at 15389 S.W. 69th Place,
Miami, Florida 33193

ARTICLE TWO

This Corporation should have perpetual existence.

ARTICLE THREE

NATURE OF BUSINESS

The general nature of business and the objects and purpose to be transacted and carried on are:

To promote through personal contact, conferences, seminars, magazines, literature, etc., the basic principles of Democracy for the defense of Freedom, Human Rights and included but not limited to Free Organization of Workers

To promote, provide and facilitate better understanding among members and governmental officials.

To promote, provide and facilitate the conservation of our culture and tradition to promote services to the consumers members or this organization, obtaining a higher educational level.

To fight against all forms of totalitarianism regimes of right or left wing, with the tool above mentioned.

ARTICLE FOUR

PROHIBITED ACTIVITIES

This organization should not conduct or carry on any activity not permitted to be conducted or carry on by any organization, except for Federal or State income taxes and

to which contributions are deductible from Federal or State income tax.

ARTICLE FIVE
DISTRIBUTION OF EARNINGS

No part of the net earnings of the Corporation, shall insure to the benefit of any private shareholder or individual within the meaning of Section 501(c) of the Internal Revenue Code as now in force or afterwards amended.

ARTICLE SIX
COMPENSATION

No compensation shall be paid to any member, officer, director, trustee, creator or organizer of the corporation or sustaining contributor to it except as a reasonable allowance for services actually rendered to or for the corporation.

ARTICLE SEVEN
BOARD OF DIRECTORS

The business affairs of this corporation shall be managed by a Board of Directors. This corporation shall have (3) directors initially. Directors will be elected annually. The numbers of directors may be increased from time to time in manner provided by the By-Laws but there shall never be less than (3) directors.

The names and the registered post office addresses of the members of the first Board of Directors, who subject to the provisions of the Certificate of Incorporation, By-Laws and the corporation laws of the State of Florida, shall hold office for the first year of the corporation's existence or until their successors are elected and have qualified are:
