**Articles of Incorporation
of
Lee County Fast Pitch Softball Association, Inc.**

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I - Name

This corporation shall be known as LEE COUNTY FAST PITCH SOFTBALL ASSOCIATION, INC., a non-profit Florida corporation.

ARTICLE II - Principle Office

The initial address of the principal office and mailing address shall be 1839 Hancock Bridge Parkway, Cape Coral, FL 33990.

ARTICLE V - Registered Agent



ARTICLE VI - Incorporators


