ARTICLE I. The name of the corporation is FLORIDA THERAPY SERVICES, INC.

ARTICLE II. This corporation may engage or transact any and all lawful activities or business permitted under the laws of the state of Florida to promote mental health through education, research, literature, and any other means of disseminating the principals of the corporation as well as to offer through the corporation, to the public at large services and forums for mental health.
