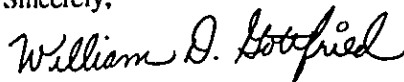

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be:

The Hungry Hearts Humanitarian Alliance Inc.

ARTICLE II

Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be:

ARTICLE III

Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code.

The Hungry Heart Humanitarian Alliance specific purpose is to provide the essential resources to individuals who are economically disadvantaged so that these people can become productive members of our society. This will be accomplished by providing the needy with temporary housing and REHABILITATION SERVICES, etc....

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

After incorporation, the directors will be elected as set forth in section 617.0205, Florida Statutes. In addition, the method of election of directors is stated in the bylaws of the corporation.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statute, unless limited are as follows:

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of this corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
