ARTICLES OF INCORPORATION
OF
TINA'S LITTLE ANGELS LEARNING CENTER, INC.

- ONE: The name of the corporation is Tina's Little Angels Learning Center, Inc. The corporation is organized pursuant to the Florida Nonprofit Corporation Code.
- TWO: The principal place of business and mailing address is 15 E. 25th St., Jacksonville, FL 32206, Duval County.
- THREE: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to: Child Care, Community Development, Land Acquisition, Housing, Health Care, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Job Training, Job Placement, Substance Abuse Awareness and Prevention, Tutoring, AIDS, and other programs to aid those in need.
- FOUR: The Directors are elected in accordance with the Bylaws. The duration of this corporation shall be perpetual, no stock and shall have no members.
- FIVE:
- (a) This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code
- SIX: The initial registered street address is 15 E. 25th St., Jacksonville, FL 32206, Duval County. The registered agent at the registered address is *Ridley W. Harshbarger*

NINE: On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for, Religious, Charitable and Educational under Section 501(c)(3) of the Internal Revenue Code.
