ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be MULTICULTURAL SOCIETY-OF ARTISTS.

ARTICLE II

The principal place of business and mailing address of this corporation shall be:

ARTICLE III

The specific purposes for which the corporation is organized are:

To draw performing artists from ethnic minorities into the mainstream cultural scene in this community;

No less than 3 nor more than 7 directors shall be elected by the incorporators in an annual meeting called for the purpose. lirectors may or may not be incorporators of this corporation.

In case of a tie, the current chairman of the Board shall cast the deciding vote.

ARTICLE V

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.
