

ARTICLES OF INCORPORATION

Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

This corporation is a not-for-profit corporation, organized under chapter 617 Florida Statutes. It is not organized for private gain of any person. Specific purpose is to provide professional teaching, healthy and safe child care, to contribute to public welfare, that God be glorified, and that spiritual enrichment will be provided. Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

Voting members who shall be elected and may be removed. Directors are elected by the application review, and names are presented by nomination or personal inquiry. Then application is filled in. Then turned to the determining committee.

ARTICLE III (Purpose(s) CONTINUED
