ARTICLE I

Name

The name of this Corporation is The Lamb Temple of God Pentecostal Church, Inc.

ARTICLE II

Address

The principle office of this Corporation is Rock of Ages Chapel. The mailing address of this Corporation is 2204 S. Monroe Street Tallahassee, Florida

ARTICLE III

Corporate Nature

This is a nonprofit corporation, organized solely for general purposes pursuant to the "Florida Not for Profit Corporation Act," set forth in Section 617 of the Florida Statutes.

(a) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth in Article IV hereof.

(b) No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate

in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

(c) Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

#### ARTICLE IV

##### Corporate Purpose

This Corporation was organized for the following lawful purposes:

- (a) Church and related religious activities.
- (b) Any other lawful purposes.

(c) Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in the furtherance of the purposes of this corporation.

#### ARTICLE V

(a) Board of Directors. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors. The number of Directors of the corporation shall be not less than ~~one~~ <sup>THREE</sup>, provided, however, that such number may be changed by a bylaw duly adopted by the members. The Directors named herein as the first Board of Directors shall hold office until the first meeting of members at which time an election of

of Directors shall be held. The method of election of Board of Directors shall be stated in the by-laws.

(b) Corporate Officers. The Board of Directors shall elect the following officers: President, Vice-President, Secretary, Treasurer, and such other officers as the bylaws of this corporation may authorize the Directors to elect from time to time. Initially, such officers shall be elected at the first annual meeting of the Board of Directors.

#### ARTICLE VI

##### Articles of Dissolution

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1954 (or other corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction in the county in which the principal office of the corporation is then located,



exclusively for such purposes or to such organization or organizations as such Court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE VII

##### Membership

(a) The corporation shall have one class of members and no more than one membership may be held by any one person. The rights and privileges of all members shall be equal. Each member shall be entitled to one vote.

(b) Any person paying the dues provided for by the bylaws and agreeing to be bound by the Articles of Incorporation and the Bylaws of the corporation and by such rules and regulations as the trustees may from time to time adopt, is eligible for membership.

(c) A prospective member shall be eligible for membership upon presentation of an approved application by membership committee for approval and acceptance by the Board of Directors.

## ARTICLE IX

### Amendment of Bylaws

Subject to the limitations contained in the Bylaws, and any limitations set forth in the "Florida Not for Profit Corporation Act," corporate action must be authorized or approved by the members of the corporation. Bylaws of this corporation may be made, altered, rescinded, added to, or new Bylaws may be adopted, either by a resolution of the Board of Directors, or by a procedure set forth in the Bylaws.

## ARTICLE X

### Dedication of Assets

The property of this corporation is irrevocably dedicated to benevolent, civic, cultural, educational, and charitable purposes, and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof, or to the benefit of any private individual.

## ARTICLE X

### Registered Agent

The address of the corporation's registered office shall be 2730 Lake Henrietta Street Tallahassee, Florida 32310 its registered agent at said address shall be Ulice Smith

## ARTICLE XI

### Amendment of Articles

Amendments to these Articles of Incorporation may be proposed by a resolution adopted by the Board of Directors and presented to a quorum of members for their vote.
