ARTICLE I

The name of this corporation shall be VETERANS LIFE CENTER, INC.

ARTICLE II

The members of the corporation shall be any U.S. veteran of any war and any family member of any U.S. veteran.

ARTICLE III

The principal place of business and mailing address of this corporation shall be:
911 W. Caroline Boulevard, Panama City, Florida 32401.

ARTICLE IV

The specific purposes for which this corporation is organized are:

1. Provide housing for all U.S. veterans of all wars and their families;
2. Provide education for all U.S. veterans of all wars and their families;
3. Provide child placement services for all U.S. veterans of all wars; and
4. Provide services and counseling regarding the veteran's relationship with the United States Veterans Administration.

ARTICLE V

The manner in which the directors are elected or appointed shall be set forth in the corporation's by-laws.

ARTICLE VI

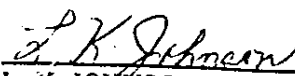
