(A corporation not for profit organized under Florida Statute Section 617.013):

The undersigned hereby certifies:

(a) <u>Name</u>. The name of the corporation shall be: CONGREGATION ACHVATT ISRAEL, INC.

(b) <u>Commencement</u> and <u>Duration</u>. The duration of the corporation shall be perpetual, and the corporate existence shall commence upon the filing of these Articles of Incorporation by the Department of State.
