The Board of Directors of THE SUNSHINE ACADEMY AND DAYCARE CORPORATION, request that the provisions below, typed in BOLD, be added to the Articles of Incorporation of THE SUNSHINE ACADEMY AND DAYCARE CORPORATION. The purpose of the additions is to meet the organization test for exemption under section 501(c)(3) of the IRS code.

Revised Articles reads as follows:

### **ARTICLE II- GENERAL PURPOSES**

The purpose of the corporation shall be to provide a nursery and daycare center for preschool and young school children of the community, constituted from a Christian perspective in a Christian atmosphere. The care, instruction and activity shall conform to the Christian Faith, as perpetuated and promulgated by the Church of God Reformation Movement (General Offices, Anderson, Indiana).

This corporation is organized exclusively for Charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

### ARTICLE IX - CAPITAL STOCK

This corporation shall have no capital stock and none of its earnings shall inure in whole or in part to the benefit of any individual, member, officer or director, and, If for any reason the corporation shall cease to exist, dissolve or be terminated as a legal entity, all of its assets, real and personal, shall be distributed to the First Church of God of Bradenton, Florida, 2520 43rd Street West, Bradenton, Florida, a qualified 501(C)(3) organization.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
