TO WHOM IT MAY CONCERN:

On December 7, 2003, we sent the attached letter and check to you requesting waiver of the 2003 reinstatement fee since the annual report forms were not received. We enclosed a check for the 2003 corporate annual report in the sum of \$61.25. We assumed the corporation was being reinstated until recently when we checked and found that it was not. We called and were told that the check had been returned with a corporate report form that needed to be filled out.
