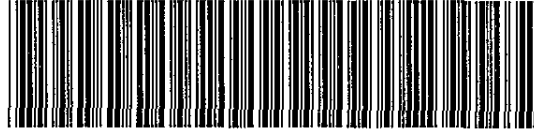

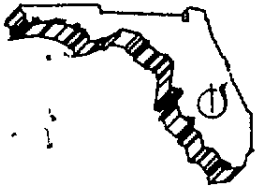

FIRST: Amendment(s) adopted: Article has been adopted for amendment to the Articles Of Incorporation to reflect the requirements of the Internal Revenue Service code pursuant to the application made for tax exemption under section 501(c) (3) .The following amendment was added on August 31, 2003 at a meeting held by the directors and members of the West Broward Church Of God.

(A) The organization is organized exclusively for charitable, religious, educational and or scientific purposes under section 501 (c) (3) of the Internal Revenue Code.


