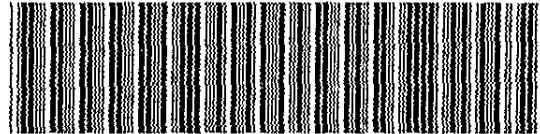



## ARTICLE XII Rules & Regulations

12.01 A green or black chain link fence may be permitted. The maximum height shall be six feet. The chain link fence shall not extend beyond the front side of the homeowners building. A plastic privacy fence in the colors of black, green or white, will also be permitted inside the perimeter of the black iron fence which surrounds the development.
