**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION
OF
HISPANIC BUSINESS INITIATIVE FUND, INC.**

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, this Florida not for profit corporation hereby adopts the following amendment to its Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is HISPANIC BUSINESS INITIATIVE FUND, INC. (hereinafter referred to as the "Corporation"), Florida document number N95000004777.

ARTICLE II - TEXT OF AMENDMENT

Article I of the Articles of Incorporation is amended in its entirety by replacing it with the following:

"ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be PROSPERA
INITIATIVES, INC. (the "Corporation")."

ARTICLE III – ADOPTION OF AMENDMENT
