ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

OF

OVEREATERS: "THE H.O.W. CONCEPT", A 12 STEP FELLOWSHIP, INC

Pursuant to the provisions of Sections 617.1001, 617.1002 and 617.1006, Florida Statutes, OVEREATERS: "THE H.O.W. CONCEPT", A 12 STEP FELLOWSHIP, INC., a Florida not-for-profit corporation (the "Corporation"), hereby adopts the following amendments to its Articles of Incorporation:

1. Article I of the Corporation's Articles of Incorporation is hereby amended in its entirety and replaced with the following:

ARTICLE I. NAME
