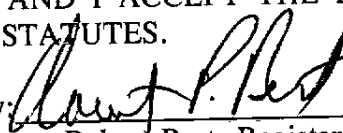
1. The name of the corporation is **THE ISPE FOUNDATION, INC.** ("Corporation")
