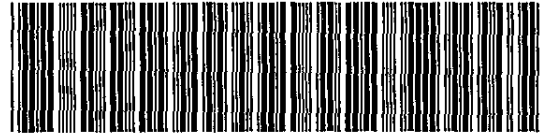


Pursuant to Section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: The amendment adopted was to the Name of the Corporation. The name of the corporation shall be:

NAVY LEAGUE OF THE UNITED STATES CLEARWATER COUNCIL, INC.

SECOND: The Board of Directors, at its regular meeting February 5, 2003, resolved to change the name to "Navy League of the United States, Clearwater Regional Council.". Authority to change the name to "Navy League of the United States Clearwater Council" was granted by the National Headquarters of the Navy League of the United States with an effective date of March 4, 2003. At its regular meeting April 3, 2003, the Board of Directors amended its previous resolution to agree with the authority of National Headquarters. The effective date of the changed name is March 4, 2003.

THIRD: There were no members entitled to vote on the amendment to the Articles Incorporation to change the name of the corporation. The amendment was adopted by the board of directors.
