Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

A residential facility housing 24-36 pregnant adolescent teens. The purposes are to reduce the count of early teen pregnancy on the streets and in unwanted homes; cut the cost of welfare/government spending; lower the rates of young female school drop outs while at the same time provide and enforce the need and rewards of education, employment and in independence.

The manner in which the directors are elected or appointed is as follows:

Articles of Incorporation/Organization

The corporation is organized exclusively for charitable, educational, religious or scientific purposes, within the meaning of section 501 (c) (3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

ARTICLE VIII

No part of the net earnings of the corporation shall inuue to benefit of, or be distributable to its members trustess, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in futherance of section 501 (c) (3) purposes. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candiate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on:

- (a) by a corporation/organization exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code) or
- (b) by a corporation/organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

Upon dissolution of this corporation assest shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any future federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purposes.
