Amendments Adopted

Article II Section I B Added- To preserve the heritage and cultural identity as assimilation into the American way of life.

Article III Section I Deleted- Membership to this association is open to every adult person of Cavite origin including his/her spouse provided they are of good moral character.

Article III Section I Added- Any cavitenios of the age of eighteen years or older shall be eligible for membership provided that such person is not a fugitive of the law of any kind.

Article IV Section 4 Added- The executive committee will appoint a five member nominating committee consisting of one chairperson. Nomination will take place during the month of October.

Article IV Section 5 Added- The nominating committee will report to the executive committee in November with all qualifiers and final candidate for the general election in January.

Article IV Section 6 Added- All elected and appointed officers shall assume office after the induction of officer in the month of March.

Article IV Section 7 Added- Officers must be of Cavite origin and at least 18 years of age or older.

Article IV Section 8 Added- President, First Vice President must be of the Cavite origin and at least thirty years old or older and a member of the association for one year.

Article IV Section 9 Added- Elected officer must not hold an election office in any other organization.

Article V Section 2 Deleted- The Vice President

Article V Section 2 Added- The First Vice President

Article V Section 2 Added- The Second Vice President will assist the President and shall have the same power to perform all the duties of the President in case of the inability of the President and the First Vice President to act.

Article V Section 12 Added- The Historian shall prepare a narrative account of activities and event for the association record during his/her term in office.

Article V Section 13 Added- The editor shall prepare all publication newsletter, etc.

Article V Section 14 Added- The Area Representative shall maintain close contact with the members in their respective areas for information in regard to the association activities.
