#### ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

#### NORTHLAND FOUNDATION FOR THE ARTS AND EDUCATION, INC.

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, NORTHLAND FOUNDATION FOR THE ARTS AND EDUCATION, INC., a Florida non-profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is NORTHLAND FOUNDATION FOR THE ARTS AND EDUCATION, INC.
- 2. The original Articles of Incorporation for the Corporation were filed on November 8, 1995, and assigned Charter No. N95000005317.
- 3. By a unanimous written consent executed on March //, 2009 by the directors, namely, the Board of Governing Elders of Northland A Church Distributed, Inc. (the "Board of Governing Elders") have approved, authorized, and directed that Article I and Article III of the Corporation's Articles of Incorporation be amended. There are no members entitled to vote on the amendment, and the amendment was adopted by the Board of Governing Elders.
- 4. Article I of the Articles of Incorporation is hereby amended in its entirety to read as follows:

## ARTICLE I – NAME OF CORPORATION, MAILING ADDRESS AND ADDRESS OF PRINCIPAL OFFICE

The name of this Corporation shall be TRUE NORTH FOUNDATION, INC. The mailing address of the corporation and the principal address of the corporation shall be 530 Dog Track Road, Longwood, Florida 32750.

5. Article III of the Articles of Incorporation is hereby amended in its entirety to read as follows:

#### ARTICLE III – POWERS, OBJECTS AND PURPOSES

The primary purpose for which this Corporation is formed is to promote the Gospel message of Jesus Christ to the Church and the world through Worship, Service, and Equipping. The Corporation will also seek to provide church planting through sites development.

This Corporation shall be authorized to exercise the powers permitted nonprofit corporations under Chapter 617 of the Florida Statutes; provided, however, that this Corporation, in exercising any one or more of such powers, shall do so in furtherance of the exempt purposes for which it has been organized within the meaning of Section 501(c) (3) of the Internal Revenue
