AMENDMENT TO ARTICLES OF INCORPORATION OF

NATIONAL COMMUNITY DEVELOPMENT, INC.

97.MAR 28 AM II: 12 SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, as President of NATIONAL COMMUNITY DEVELOPMENT, INC., hereby certifies that the following amendments to the Articles of Incorporation of NATIONAL COMMUNITY DEVELOPMENT, INC. were duly ratified and approved by the unanimous consent of all Officers and Directors:

There are no members entitled to vote.

The following paragraphs shall be added to the Articles of Incorporation of NATIONAL COMMUNITY DEVELOPMENT, INC. and shall be effective as of the day and year appearing below.

Notwithstanding any of the terms and conditions of the Articles of Incorporation, the following Articles shall supersede and be effective as of the day and year appearing below.

Article VII: The purposes of the corporation shall be exclusively for religious, charitable, scientific, literary and educational, within the meaning of Section 501(c)(3) of the Internal Revenue Code, 1986, or the corresponding provision of any future United States Internal Revenue Law.

Article VIII: Notwithstanding any of the other provisions contained in the Articles of Incorporation, this corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code, 1986, or the corresponding provision of any future United States Internal Revenue Law.

Article IV: Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding Section of any future Federal Tax Code, or shall be distributed to the Federal Government or to a State or local government, for a public purpose. Any such assets not disposed of shall be disposed by the Court of Common Pleas of the County

of which the principal office of the corporation is then located, inclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operating exclusively for such purposes.

IN THE WITNESS WHEREOF, this Amendment to Articles of Incorporation shall be adopted as of the 3/ day of January, 1997.
