CERTIFICATE OF AMENDMENT

WORD ALIVE MINISTRIES, INC.

WORD ALIVE MINISTRIES, a corporation of the State of Florida, certifies pursuant to the provisions of Chapter 617, Florida Statutes, that at a meeting of the members of said corporation called for the purpose of amending the Articles of Incorporation, and held on February 16,1999, it was resolved by the vote of the members of an appropriate majority entitled to vote that ARTICLE III and V of the Articles of Incorporation are amended to read as follows:

ARTICLE III PURPOSES

This is not for profit corporation. The specific purposes for which the corporation is organized is to worship and honor the Lord Jesus Christ in preaching and teaching the Holy Bible, conducting worship services and prayer meeting, supporting mission efforts, and reaching out and ministering to the physical and spiritual needs of others in the name of Jesus Christ. Said corporation is organized exclusively for religious purposes, within the meaning of section 501©(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section of any future federal tax code) or (b) by a corporation contributions to which are deductible under Section 170©(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

ARTICLE V LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in Section 617.0302. No part of the net earnings of the corporation/ shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501©(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
