The undersigned subscriber to these Articles of Incorporation is natural person competent to contract and hereby form a non profit Corporation under Chapter 61.7 of the Florida Statutes.

#### ARTICLE 1 - NAME

The name of the Corporation is EXODUS INTERNATIONAL CORP., (hereinafter "Corporation").
