**AMMENDMENT TO THE
ARTICLES OF INCORPORATION
OF**

BLANCHE ELY HIGH CLASS OF 1970, INC.

A NON-PROFIT CORPORATION

Pursuant to the provisions of the Florida Not For Profit Corporation Act, the undersigned hereby adopts the following Articles of Incorporation:

ARTICLE 1- NAME

The name of the this Corporation is Blanche Ely High Class of 1970, Inc., (hereinafter "Corporation").

ARTICLE 2- INITIAL PRINCIPAL OFFICE

The address of the initial principle office and the registered office of the Corporation is 3333 W. Atlantic Blvd., Suite 16 Pompano Beach, FL 33069.

ARTICLE 3- PURPOSE

The purpose for which this corporation is organized is to establish a cultural African-American art center for children, young people and adults, making available the talent and priceless works of art for study and enjoyment which may be found in rich abundance in the community and elsewhere; and to acquire, construct, maintain and operate any and all building and equipment which may be necessary or convenient in connection therein.

Blanche Ely High Class of 1970, Inc. A non-for profit organization will hold a multicultural event in the fine art designed to explore artistic media and to expose the entire City of Pompano Beach, Florida to the African/American Cultural Arts and Heritage, and their achievements around the world, as well as Broward County.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of the future United States internal revenue law, or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 of the corresponding provision of any future United States internal revenue law.

Upon dissolution of this corporation, its assets remaining after payment, or provision for payment of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

This corporation shall be a not-for-profit organization incorporated and chartered by the laws of the State of Florida.

ARTICLE 6- OFFICERS

The affairs of the this corporation shall be managed by officers elected by the Board of Directors at its annual meeting. The officers shall serve until the next annual meeting of the Board of Directors, unless removed earlier in accordance with the bylaws.

ARTICLE 7- DIRECTORS

This Corporation shall have a Board of Directors elected in accordance with its bylaws. The number of directors shall be prescribed in the bylaws from time to time, but at no time shall be less than seven (7) in number.

ARTICLE 8- BYLAWS

The by laws of the Corporation shall be adopted by the Board of Directors.


ARTICLE 9- AMENDMENTS

An amendment to these articles may be proposed by the Board of Directors.

ARTICLE 10- REGISTERED OFFICE AND REGISTERED AGENT

The initial registered agent for this Corporation is Edward Phillips and initial registered office is located at 3333 W. Atlantic Blvd., Suite 16 Pompano Beach, FL 33069.
