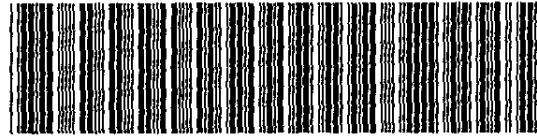

December, 2005.


**ARTICLE I. NAME**






