## Articles of Incorporation THE DOVE OF THE FLORIDA KEYS, I

The undersigned, acting as incorporator of a corporation pursuant to Chapter  $\hat{\theta}$  Statutes, adopts the following articles of incorporation for such corporation.

## ARTICLE 1 NAME and PRINCIPAL ADDRESS

The name of the corporation is: **THE DOVE OF THE FLORIDA KEYS, INC.**, and the initial principal address of the corporation is: County Road, Lot 4, Seahorse Trailer Park, Big Pine Key, Florida 33043.

#### ARTICLE II PURPOSE

The purposes for which the corporation is organized are: to publish and distribute Christian literature, to conduct ministry and provide assistance to those in need. The corporation is organized for any lawful purpose not for pecuniary profit and not specifically prohibited to corporations under the laws of the State of Florida.
