ARTICLES OF INCORPORATION OF WORLDWIDE OVERSEAS MISSIONS/EVANGELIZING NATIONS EFFECTIVE DATE 1-1-91.

The undersigned being desirous of forming a corporation not for profit under the provisions of Chapter 617 of the Florida Statues, and, in accordance with all pertinent laws of the State of Florida, does hereby subscribe and adopt the following Articles of Incorporation for such corporation:

ARTICLE I

Name and Principal Place of Business

The name of this corporation shall be , Worldwide Overseas Missions/Evangelizing Nations, Inc. The intial principal place of business of the corporation shall be 6002 North Main Street, Jacksonville, Florida 32208.

ARTICLE II

<u>Duration</u>

The period of duration of the corporation is perpetual, unless dissolved according to law. Corporate existence shall commence on January 1, 1996, with the filling of these Articles of Incorporation with the Secretary of State of Florida.

ARTICLE III

<u>Purposes</u>

This corporation is organized exclusively for charitable and educational purposes. The corporation's purposes are as following:

- (a) To promote Worldwide Overseas Missions/Evangelizing Nations among local, national and international fellowships worldwide.
- (b) To cultivate among the world's people love and respect for Christian culture and arts internationally through crusades, film showing, bible studies, lectures, seminars programs, shows, concert, dramas, plays and other similar means.
- (c) To educate people, including the young, on things of Christ, by making available bible school scholarships.
- (d) To develop and enhance individual and group leadership qualities of members by holding local, national and international workshops and leadership seminars.
- (e) To develop illustrative and merciful share/care vocational and agricultural training programs and provide food supplements, clothing and housing.

- (f) To develop and use Telecommunication and other technologies to carry out the purposes of the organization;
- (g) To receive donations, contributions, gifts, legacies, endowments, loan or financial aid from whatever source; to invest and re-invest the funds collected and from the income whatever thereof, pay or apply the entire net income together with the principal or such part thereof as shall from time to time may be necessary to carry out the objectives of the foundation; provided, that not more than 30% of the total gifts, bequests, donations and contributions shall be spent for administrative purposes.
- (h) To purchase, develop, manage, operate, sell, mortgage, lease, pledge, assign and otherwise acquire, dispose of or encumber properties real or personal, and maintain such offices and employ such personal as may be necessary to carry out the purposes:
- (i) Generally to do all things, transact business, exercise such power or authority as may be directly or indirectly necessary incidental or expedient to carry out the purpose and objectives above specified; but the purpose and essence of the corporation being mainly Jesus Christ centered.

Notwithstanding any other provision of these Articles of Incorporation, the purposes for which the corporation is organized are exclusively charitable and educational within the meaning of section 501 (c) (3) of the Internal Revenue code of 1986, as amended, or the corresponding provision of any future federal tax code.

ARTICLE IV

Members

The qualifications for members and their manner of admission shall be regulated by the Bylaws of the corporation.

ARTICLE V

Board of Directors

The intial Board of Directors of this corporation shall consist of five members, and the names and addresses of the persons who are to serve initially are as follows:

The number of directors may be increased or decreased from time to time as provided in the Bylaws, but shall never be less than three.

ARTICLE VI

Non-stock

'The corporation is organized on a non-stock basis.

ARTICLE VII

Dissolution

In the event of dissolution, the residual assets of the corporation will be turned over to one or more organizations which themselves are exempt as organizations decribed in Section 501 (c) (3) and 170 (c) (2) of the Internal Revenue code of 1986, as amended, or corresponding sections of any prior or future law, or to the Federal, State, or local Government for exclusive public purposes.

ARTICLE VIII

Powers

The corporation shall have all powers provided for corporations not for profit by chapter 617 or chapter 607 of the Florida Statues, or corresponding provisions of any subsequent statute, and all the power of any other statute or law which do not in any way adversely affect the corporation's status as a corporation not for profit under Chapter 617 of the Florida Statutes

ARTICLE X

<u>Limitation on Activities</u>

(a) No part of the net earnings of the corporation shall inure to the benefit of , or be distributable to its members , trustees , officers, or other private persons ,except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda , or otherwise attempting to influence legislation , and the corpation shall not participate in , or intervene in (including the publishing or distribution of statement) any political campaign on

behalf of any other provision of these Articles of Incorporation , the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code , or corresponding section of any future federal tax code , or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

- (b) In the event that the Corporation is classified as a private foundation as defined in Section 509 of the Internal Revenue Code of 1986 (or corresponding provisions of any subsequent federal tax laws);
- (1) The Corporation shall distribute its income for each taxable year at such time and in such manner as not to subject it to the tax on undistributed income imposed by Section 4942 of the In ternal Revenue code of 1986 (or corresponding provisions of any subsequent federal tax laws).
- (2) The Corporation shall not engage in any act of self-dealing as defined in section 4941 (d) of the Internal Revenue Code of 1986 (or corresponding provisions of any subsequent federal tax laws).
- (3) The Corporation shall not retain any excess business holding as defined in Section 4943 (c) of the Internal Revenue Code of 1986 (or corresponding provisions of any subsequent tax laws).
- (4) The Corporation shall not make any investment in such manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1986 (or corresponding provisions of any subsequent federal tax laws).
- (5) The corporation shall not make any taxable expenditures that wold subject it to tax under Section 4945 (d) of the Internal Revenue Code of 1986 (or corresponding provisions of any subsequent federal tax laws).
